PRODUCTION OF PALM OIL

1728. SHRI MADDILA GURUMOORTHY: DR. SANJEEV KUMAR SINGARI:

Will the Minister of CONSUMER AFFAIRS, FOOD AND PUBLIC DISTRIBUTION उपभोक्ता मामले, खाद्य और सार्वजनिक वितरण मंत्री be pleased to state:

- (a) the details of total production and demand of palm oil, state-wise, in the last three years;
- (b) the details of total exports and imports of palm oil, including the country of export/import, in the last three years;
- (c) whether it is true that India is experiencing a shortage of palm oil;
- (d) if so, the details thereof and the reasons for the same;
- (e) whether the Government has taken any steps to enhance the domestic production of palm oil to reduce import reliance; and
- (f) if so, the details thereof?

ANSWER

MINISTER OF STATE FOR MINISTRY OF RURAL DEVELOPMENT AND CONSUMER AFFAIRS, FOOD & PUBLIC DISTRIBUTION (SADHVI NIRANJAN JYOTI)

- (a): The state-wise production of palm oil in the last three years (2019-20 to 2021-22) is at Annexure I. The demand for palm oil is mainly in the HoReCa sector (Hotel, Restaurant and Café) and its derivatives are also used in making chocolates, biscuits, noodles, soaps, lipsticks etc. in the country.
- (b): The details of total exports and imports of palm oil including the country of export/import in the last three years (2019-20 to 2021-22) is at Annexure II.
- (c) and (d): Domestic production of edible oils is unable to meet the domestic demand and the gap between demand and supply of edible oils is met through imports. Out of the total imports, palm oil constitutes 61.80%.
- (e) and (f): The Government of India has launched National Mission on Edible oils- Oil Palm (NMEO-OP) during the year 2021 with the aim to enhance the edible oils availability in the country by harnessing Oil Palm area expansion, increasing Crude Palm Oil (CPO) production and to reduce the import burden on edible oils. The Mission has a target of covering additional area of 6.5 Lakh hectare under Oil Palm plantation with 3.28 lakh hectare in north-eastern states and 3.22 lakh hectare in Rest of India in next 5 years from 2021-22 to 2025-26.
