(a) to (d): Ministry of Tourism, promotes India in a holistic manner. As part of its on-going activities, it releases global print, electronic and online media campaigns in important and potential markets overseas, under the 'Incredible India' brand-line, to promote various tourism destinations and products of the country.

Rural Tourism encompassing agri-tourism has been identified as a Niche Tourism product for development.

Ministry of Tourism has instituted a National Tourism Award in the category of 'Best Rural/Agri/Plantation Tourism projects' to motivate the stakeholders in the tourism sector for implementing such projects.

Ministry of Tourism has formulated a National Strategy and Roadmap for Development of Rural Tourism in India- An initiative towards Atmanirbhar Bharat. The strategy document focuses on the following key pillars:

- i. Model policies and best practices for rural tourism
- ii. Digital technologies and platforms for rural tourism
- iii. Developing clusters for rural tourism
- iv. Marketing support for rural tourism
- v. Capacity building of stakeholders
- vi. Governance and institutional framework
