**TARGET FOR TAP WATER ACCESS TO HOUSEHOLDS**

1879. SHRI ABHISHEK BANERJEE:

Will the Minister of JAL SHAKTI be pleased to state:

- (a) the percentage of the target of providing tap water access to all rural households by 2024 achieved by the Government along with the details thereof, State-wise;
- (b) whether the percentage of the budget allocated was utilised during the last Financial Year (FY) 2021-22 and percentage of the budget allocated in FY 2022-23 has been utilised so far and if so, the details thereof; and
- (c) the details of the number of households set as a target under the scheme for the current FY and percentage of the target achieved so far?

**ANSWER**

(a) to (c) Since August, 2019, Government of India in partnership with States is implementing Jal Jeevan Mission (JJM) to make provision of potable tap water supply to every rural household of the country, by 2024.

At the time of announcement of Jal Jeevan Mission, 3.23 Crore rural households were reported to have tap water connections. So far, 6.65 Crore households have been provided with tap water connections in last 35 months. Thus, as on 25<sup>th</sup> July 2022, out of 19.14 Crore rural households in the country, around 9.88 Crore (51.61%) households are reported to have tap water supply in their homes. State/ UT-wise details are **annexed**.

During FY 2022-23, the States/ UT have planned to provide 4.8 crore tap water connections to households. So far, 51.31 lakh households have been provided with tap water connections as on 25<sup>th</sup> July 2022 in current financial year.

In 2021-22, for Jal Jeevan Mission an amount of Rs. 45,011 Crore was made available out of which Rs. 40,125.64 Crore (89.14%) was utilized in view of the proposals received from the eligible States/ UTs. Further, during 2022-23, Rs. 60,000 Crore has been allocated. As on 25<sup>th</sup> July 2022, an amount Rs. 1,509.64 Crore has been drawn by States/ UTs. Moreover, the States/ UTs had opening balance of Rs. 19,339.51 Cr in 2022-23. So far, States/ UTs have reported the expenditure of Rs. 8,762.89 Crore in Central Share.
