HIGH BURDEN TO HIGH IMPACT

2193: SHRI SUSHIL KUMAR SINGH:

Will the Minister of **HEALTH AND FAMILY WELFARE** be pleased to state:

- (a) whether India is one of the High Burden to High Impact (HBHI) countries as far as incidence of Malaria is concerned;
- (b) if so, the details thereof;
- (c) the steps being taken by the Government to eliminate Malaria from the country along with the timeline by which the country is targeted to be Malaria free; and
- (d) the expenditure incurred by the Government on anti-malaria efforts during last five years, year-wise and State/UT-wise?

ANSWER

(a) & (b) India is one of the countries wherein World Health Organization's (WHO) High Burden to High Impact (HBHI) strategy has been implemented in 2019, in four States namely Madhya Pradesh, Chhattisgarh, West Bengal and Jharkhand. HBHI strategy included enhanced political will, resource mobilization, implementation, Monitoring and Evaluation. This has led to a reduction of 58.76% in malaria morbidity and 17.3% in malaria mortality in these States from 2018 to 2021.

(c) The Government has launched the National Framework for Malaria Elimination (NFME), 2016-2030 with a goal to eliminate malaria in the country by 2030. Following steps are taken by the Government:

- (i) For prevention, control and elimination of Malaria, budgetary support is provided to States/UTs under the overarching umbrella of National Health Mission (NHM).
 - (ii) National Center for Vector Borne Diseases Control (NCVBDC) provides technical support to States/UTs for programme implementation in terms of integrated vector management, early diagnosis & treatment, capacity building, epidemic preparedness, monitoring and evaluation etc.
 - (iii) NCVBDC takes review meetings, conducts field visits and deploys central teams in cases of outbreak like situation.
- (d) State/UT wise Central releases and expenditure under National Vector Borne Disease Control Programme (NVBDCP) for six vector borne diseases (including Malaria) under NHM during the last five years are given in **Annexure-I**.
