Will the Minister of **HEALTH and FAMILY WELFARE** be pleased to state:

- (a) the main objective and salient features of eSanjeevani along with the necessary steps taken to spread awareness about the Scheme;
- (b) the number of States/UTs where the Scheme is being operated in the country;
- (c) whether the Government has a record of beneficiaries registered and benefitted under the eSanjeevani scheme, if so, the details thereof, State/UT wise including Uttar Pradesh and West Bengal;
- (d) the number of COVID and non-COVID persons benefitted from the Scheme;
- (e) the number of people availing this service in rural areas as compared to urban areas and the necessary steps taken by the Government to promote such services in rural areas;
- (f) the number of Primary Health Centers that have been connected to telemedicine services in the country, State/UT-wise, and
- (g) the steps being taken by the Government to provide tertiary healthcare facilities through telemedicine?

**(a) to (g)** Ministry of Health and Family Welfare (MoHFW) has developed eSanjeevani, a telemedicine application which provides doctor to doctor (HWC module) and patient to doctor consultations (OPD module).

This application works on a hub and spoke model. At hub level, a specialist doctor can provide services to Health and Wellness Centers (HWCs) in rural areas. Further people in remote and rural areas can also avail services through OPD module of eSanjeevani.

States have taken initiatives such as short videos, advertisement brochures/pamphlets, etc. in local languages including through social media platforms to disseminate information about telemedicine services and to create awareness among the masses.

eSanjeevani is operational in all States/UTs. State-wise details of Patients (Covid and Non Covid) benefitted through eSanjeevani platform is available at Annexure A.

To ensure wider outreach of telemedicine services, eSanjeevani application has also been integrated with 3.74 lakh Common Service Centers (CSCs) to facilitate access to healthcare in the remote areas of the country.

Details of Primary Health Centre (PHC), Community Health Centre (CHC), Urban Primary Health Centre (UPHC) and Sub Health Centre (SHC) connected through eSanjeevani HWCs are available at Annexure B.

To provide tertiary health care services, specialist hubs have been established across the country to facilitate consultations with relevant specialists.
