(a) to (c) All 12 (twelve) Major Ports are run by the Government of India (Ministry of Ports, Shipping and Waterways). There is no Government port privatized during last three years. However, development, operation and maintenance of the Berth/Terminals at Major Ports are being done on Public Private Partnership (PPP) mode on case to case basis.
