# MINISTER OF PORTS, SHIPPING AND WATERWAYS (SHRI SARBANANDA SONOWAL)

- (a)& (b) Expansion, modernization and upgradation of Major Ports in the country is a continuous process to keep the ports abreast with new technologies, promote trade and cargo. Public- Private Partnership (PPP) Port projects are allocated on the basis of open competitive bidding to private players for a specific period on royalty sharing basis. Under PPP mode the successful bidder makes the investment for implementing the project. The list of the projects at Major Ports implemented on PPP mode is at Annexure-1.
