Will the Minister of CORPORATE AFFAIRS be pleased to state:

- (a) whether the Union Government has any details of funds provided for development of Gujarat under Corporate Social Responsibility (CSR);**
- (b) if so, the details of funds allocated by the Government agencies and private firms under CSR; and**
- (c) the details of activities carried out under the CSR fund in Gujarat?**

(a) & (b) : The broad framework for Corporate Social Responsibility (CSR) has been provided under Section 135 of the Companies Act, 2013 ('Act'), Schedule VII of the Act and Companies (CSR Policy) Rules, 2014. The CSR framework is disclosure based and companies are required to file details of CSR activities annually in the MCA21 registry. All data related to CSR filed by companies in MCA21 registry is available in public domain at www.csr.gov.in.

On the basis of annual filings made by the Companies in the MCA21 registry, the CSR spent by the companies in the State of Gujarat during the Financial Years (FY) 2016-17, 2017-18, 2018-19, 2019-20 and 2020-21 respectively are given below:
