**Funds for Samagra Shiksha Abhiyan**

**†2471. SHRI VIVEK NARAYAN SHEJWALKAR:**

Will the Minister of EDUCATION be pleased to state:

- (a) whether the Government is providing financial assistance to the State Government to upgrade the Primary schools into multidisciplinary schools under the Samagra Shiksha Abhiyan; and
- (b) if so, the details thereof State-wise including District-wise in Madhya Pradesh?

**ANSWER**

**MINISTER OF STATE IN THE MINISTRY OF EDUCATION  
(SMT. ANNPURNA DEVI)**

(a): Yes, Sir. The Department has launched the Samagra Shiksha – an Integrated Scheme for School Education by subsuming the erstwhile Centrally Sponsored Schemes of Sarva Shiksha Abhiyan (SSA), Rashtriya Madhyamik Shiksha Abhiyan (RMSA) and Teacher Education (TE) from 2018-19. It is an overarching programme for the school education sector extending from pre-school to class XII and aims to ensure inclusive and equitable quality education at all levels of school education. The scheme provides support inter-alia for establishment of new schools by up-gradation of upper primary schools to secondary schools and up-gradation of secondary schools to senior secondary schools and, thus, for establishment of composite schools. The scheme also supports strengthening of infrastructure of existing schools.

(b): Under erstwhile Sarva Shiksha Abhiyan (SSA), till 2017- 18 and Samagra Shiksha effective from 2018-19, sanction has been given for total 3.64 lakh new elementary schools, (total 204803 Primary schools and total 160047 Upper Primary Schools) and under erstwhile Rashtriya Madhyamik Shiksha Abhiyan (RMSA), till 2017- 18 and Samagra Shiksha effective from 2018-19, 13170 new secondary schools have been sanctioned, till 30.06.2022. Apart from this since 2018-19, under Samagra Shiksha, 251 secondary schools have also been upgraded upto higher secondary level and approval for additional subject/stream of study has also been given to 2261 existing higher secondary schools. State/UT-wise number of Secondary schools approved under erstwhile RMSA and Samagra Shiksha is at **Annexure-I**. Funds under Samagra Shiksha are released in lump sum to the States/UTs and not district-wise.
