(a) whether the Government has revised Rashtriya Krishi Vikas Yojana (RKVY) as Rashtriya Krishi Vikas Yojana-Remunerative Approaches for Agriculture and Allied Sector Rejuvenation (RKYY-RAFTAAR) and if so, the details along with the salient features thereof;

(b) whether the RKYY-RAFTAAR has achieved the objective for which it was launched and if so, the details thereof and if not, the reasons therefor;

(c) the details of the projects implemented and the number of beneficiaries covered thereunder during the last three years of the current year, State-wise;

(d) the funds sanctioned/spent under the yojana till date, State-wise;

(e) the challenges faced by the Government while implementing RKYY-RAFTAAR;

(f) whether the Government has reviewed the functioning of RKYY-RAFTAAR in the country and if so, the outcome thereof and the corrective measures taken by the Government for effective implementation of the Yojana; and

(g) whether this Yojana will make farming a remunerative economic activity by strengthening farmer's effort, risk mitigation and promoting agri-business entrepreneurship, if so, the details thereof?

ANSWER

MINISTER OF AGRICULTURE AND FARMERS WELFARE

(a),(b) & (g):Rashtriya Krishi Vikas Yojana (RKVY) has been revised with effect from 01.11.2017 as Rashtriya Krishi Vikas Yojana - Remunerative Approaches for Agriculture and Allied Sector Rejuvenation (RKVY-RAFTAAR) with broad objectives of making farming a remunerative economic activity through strengthening the farmer's effort, risk mitigation with more focus on development and creation of pre & post-harvest infrastructure, besides promoting agri-entrepreneurship and innovations.

1890 projects related to agriculture and allied sectors have been approved by various States/UTs for implementation under this scheme during the last three years and a total amount of Rs.7240.32 crore has been released to various State/UT Governments during this period. Besides, under Agri-entrepreneurship programme launched under the scheme from 2018-19, 1014 number of start-ups have been supported with various grass-root innovations in agricultural practices that increase efficiency and foster innovations.

(c) to (e): RKVY -RAFTAAR is a combination of project/infrastructure and beneficiary oriented scheme. Details of beneficiary oriented projects are maintained by the State Governments. State-wise allocation and release of funds under the scheme during the last three years and current year is given at annexure-I. Sector-wise projects approved under the scheme as per the data entered by the concerned State Governments in RDMIS portal of RKVY is given at annexure-II.

Regarding challenges being faced in implementation of RKVY, reviews are conducted from time to time. The scheme is being implemented as per operational guidelines and also considering various instructions issued by D/o Expenditure from time to time.

(f): NITI Aayog has undertaken the evaluation of variousCentrally Sponsored Schemes including RKVY-RAFTAAR scheme for the period2017-18 to 2019-20. The summary of the findings of the evaluation report is given at annexure-III.

Development Monitoring & Evaluation Office (DMEO), NITI Aayog has undertaken the evaluation ofRashtriyaKrishiVikasYojna-RemunerativeApproachesforAgricultureandAlliedSectorRejuvenation (RKVY-RAFTAAR) scheme. The summary of evaluation reportis asunder:

RKVY aims to ensure holistic development of agriculture and allied sectors through creation ofrequired pre and postharvest agri-infrastructure that increases access to quality inputs, storage,market facilities etc. and enables farmers to make informed choices. The scheme allows states tochoose their own agriculture and allied sector development activities as per the district/ stateagriculture plan. RKVY has been successful in motivating states to pay greater attention to agriculture, besides providing increased Central assistance for the sector. As per output indicators defined for the scheme, all eligible states under the scheme have been utilizing funds allocated under RKVY scheme.

A web-based RKVY-Management Information System (RKVY-MIS) has been put in place to collect essential information related to each project. States are responsible for timely submission/updating project data online in the system. Financial monitoring of progress of RKVY projects is done through field visits and meetings. Monitoring also happens through MIS and geo-tagging.
