#### SVEP IN ANDHRA PRADESH

#### 2596. SHRIMATI CHINTA ANURADHA:

Will the Minister of RURAL DEVELOPMENT be pleased to state:

- (a) the details of villages in Andhra Pradesh where the Start-up Village Entrepreneurship Programme (SVEP) is being implemented, district-wise;
- (b) the details of beneficiaries under the programme along with the number of women beneficiaries during the last three years;
- (c) whether the Ministry has undertaken any study to review the functioning of the programme; and
- (d) if so, the details thereof and if not, the reasons therefor?

#### **ANSWER**

### MINISTER OF STATE IN THE MINISTRY OF RURAL DEVELOPMENT (SADHVI NIRANJAN JYOTI)

- (a) & (b) Start-up Village Entrepreneurship Programme (SVEP) is implemented in eight blocks in Andhra Pradesh. Under SVEP, the unit of implementation is block. The details regarding the villages and number of beneficiaries under the SVEP programme for last three years is at Annexure.
- (c) & (d) The mid-term review of the SVEP programme was conducted during 2018-19 by Quality Council of India (QCI). The key findings of the evaluation are:
  - i. 82% of entrepreneurs across the blocks reported being from SC, ST and OBC categories.
  - ii. 75% of the enterprises were owned and managed by women.
- iii. 57% of the total household income is through the enterprises promoted under SVEP.
- iv. Average gross income of the entrepreneurs is higher than the aspirational income stated by them from the enterprise at the time of starting the enterprise.
- v. Around 96% of the entrepreneurs reported an enhancement in savings.
- vi. 70% of the entrepreneurs interviewed reported that taking loans from Community Enterprise Fund (CEF) was easy.
