- (a) whether the Government has district-wise details of setting up of processing and chilling infrastructure and installation of electronic milk adulteration testing equipment at the village level in Rajasthan under Dairy Processing and Infrastructure Development Fund and if so, the details thereof:
- (b) whether the Government has received applications from capital stressed milk cooperatives for subsidized loan @6.5 per cent; and
- (c) if so, the total funds disbursement to the different applicants and the criteria for selection of such applicants under the said scheme, State-wise and district-wise including the States of Madhya Pradesh, Uttar Pradesh, Gujarat, Odisha and Rajasthan?

ANSWER

MINISTER FOR FISHERIES, ANIMAL HUSBANDRY AND DAIRYING (SHRI PARSHOTTAM RUPALA)

- (a) Department of Animal Husbandry and Dairying has received only one project for establishment of new dairy plant of 5 Lakh Litres Per Day (LLPD) capacity from Bhilwara Milk Union, with total outlay of Rs. 79.33 crore (loan component: 59.77 crore) under Dairy Processing and Infrastructure Development Fund from Rajasthan. The project has been sanctioned and loan of Rs. 49.95 Crore has been disbursed for implementation of the project.
- (b) and (c) Dairy processing and Infrastructure Development Fund (DIDF) is a demand driven scheme, As on 30.06.2022, 36 projects have been sanctioned and Rs. 1294.93 Crore loan has been disbursed for sanctioned projects. The State wise and milk union wise details of financial progress under DIDF as on 30.06.2022 is annexed. Financial assistance under DIDF will be given to those eligible end borrowers (EEBs) who are making profit and is having positive net worth and willing to avail funds. No project proposal has been received from Odisha and Uttar Pradesh under DIDF.
