Centrally Sponsored Schemes

2609. SHRI B. B. PATIL:

Will the Minister of **FISHERIES, ANIMAL HUSBANDRY AND DAIRYING**, मत्स्यपालन पशुपालन और डेयरी मंत्री be pleased to state:

- (a) the list of various Central Sector/Centrally Sponsored Schemes for Fisheries, Animal Husbandry and Dairying under which central funds are released by the Government;
- (b) the objectives, annual budget, contribution share of States and eligibility of beneficiaries under such schemes;
- (c) whether any study has been undertaken or is proposed to assess the impact of the above schemes and if so, the details thereof; and
- (d) the financial assistance provided to the State of Telangana during each of the last three years and the current year, district-wise and scheme-wise?

ANSWER

THE MINISTER OF FISHERIES, ANIMAL HUSBANDRY AND DAIRYING

(SHRI PARSHOTTAM RUPALA)

(a): The Ministry of Fisheries, Animal Husbandry and Dairying, Government of India has been implementing the following schemes across the country including in the State of Telangana for development of fisheries, animal husbandry and dairy sectors:-

- (i) Pradhan Mantri Matsya Sampada Yojana (PMMSY),
- (ii) Fisheries and Aquaculture Infrastructure Development Fund (FIDF),
- (iii) Rashtriya Gokul Mission (RGM),
- (iv) National Livestock Mission (NLM),
- (v) National Programme for Dairy Development (NPDD),
- (vi) Animal Husbandry Infrastructure Development Fund (AHIDF),
- (vii) Livestock Health and Disease Control Programme (LHDCP) including National Animal Disease Control Programme
- (viii) Dairy Processing and Infrastructure Development Fund (DIDF),
- (ix) Supporting Dairy Cooperatives and Farmer Producer Organizations engaged in dairy activities (SDC&FPO),
- (x) Livestock Census and Integrated Sample Survey (LC & ISS)

(b) The objectives of the aforesaid schemes include: a) to enhance fish production and productivity in a sustainable manner, development of post-harvest infrastructure and modernization and strengthening of value chain, traceability, establishing a robust fisheries management framework and fishers' welfare, b) To enhance productivity of bovines and increasing milk production in a sustainable manner using advance technologies, c) To promote indigenous cattle & buffalo rearing and conservation in a scientific and holistic manner, d) entrepreneurship development and breed improvement in poultry, sheep, goat and piggery including feed and fodder development, e) to enhance quality of milk and milk products and increase share of organized procurement, processing, value addition and marketing and f) to improve the animal health by way of implementation of prophylactic vaccination programmes against various diseases of livestock and poultry, capacity building, disease surveillance and strengthening of veterinary infrastructure.

The scheme-wise Annual Budget allocated for the current financial year 2022-23 is furnished as below:

(c) and (d): The Ministry of Fisheries, Animal Husbandry and Dairying, Government of India through various schemes has been complementing and supplementing the efforts of the State Governments/Union Territories (UTs) for promotion and development of animal husbandry, dairy and fisheries sectors and in achieving the sustained and higher growth in these sectors. The central funds under various demand driven Central Sectors/ Centrally Sponsored Schemes are released based on the viable proposals received from the States/UTs. Further, review meetings, workshops, seminars, trainings, awareness/ outreach programs are also conducted regularly at the National and Regional levels to promote and monitor the progress in the fisheries and animal husbandry sectors in the country and also to ensure speedy implementation of the schemes. In the year, 2020, NITI Aayog has carried out a Mid Term Evaluation of the Centrally Sponsored Schemes implemented by the Ministry of Fisheries, Animal Husbandry & Dairying. The district-wise funds allocation is decided by respective State Governments depending on the potential for development of fisheries, animal husbandry and dairy resources of the district under the various Central Sector/Centrally Sponsored Schemes implemented by the Ministry of Fisheries, Animal Husbandry and Dairying, Government of India. The details of scheme-wise financial assistance provided to the State Government of Telangana under each of aforesaid schemes during the last three years and the current year is as under below:
