PMGSY FUNDS IN WEST BENGAL

2631. SHRI RAJU BISTA:

Will the Minister of RURAL DEVELOPMENT be pleased to state:

- (a) the total funds sanctioned and allocated for construction of roads in the country, State and districtwise including the details under PMGSY scheme in the last three years, in the districts of Darjeeling, Kalimpong and Chopra Block under North Dinajpur district, West Bengal;
- (b) the details of works undertaken and undergoing under Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS) for the last three years, in the districts of Darjeeling, Kalimpong and Chopra Block under North Dinajpur district, West Bengal; and
- (c) the total funds allocated under MGNREG Scheme, block-wise under Darjeeling and Kalimpong districts?

ANSWER

MINISTER OF STATE IN THE MINISTRY OF RURAL DEVELOPMENT (SADHVI NIRANJAN JYOTI)

(a) Central funds under Pradhan Mantri Gram Sadak Yojana (PMGSY) are released to State Government as a whole. Further funds are released at district and sub-district level by the State Government. The release of funds to the State for implementation of PMGSY is done on the basis of the proposal received from the state and depends, inter-alia, on works in hand, execution capacity of the State and unspent funds available with the State.

State-wise details of Central fund released for construction of roads under PMGSY in the last three years and the current year are given at **Annexure-I.** As reported by the State, details of expenditure incurred (including State share) in the Darjeeling, Kalimpong districts and Chopra Block under North Dinajpur District are given at **Annexure-II**

(b)&(c) Mahatma Gandhi National Rural Employment Guarantee Scheme (Mahatma Gandhi NREGS) is a demand-driven wage employment scheme which provides for the enhancement of livelihood security of the households in rural areas of the country by providing at least one hundred days of guaranteed wage employment in every financial year to every household whose adult members volunteer to do unskilled manual work.

There is no State/District/Block wise allocation of funds under Mahatma Gandhi NREGS. Also, funds are not directly released to Districts/Blocks under Mahatma Gandhi NREGS.

Details of works undertaken in the districts of Darjeeling, Kalimpong, and Chopra block of Dinajpur Uttar in the State of West Bengal under Mahatma Gandhi NREGS in the last three financial years and the current year are given at **Annexure-III**.
