PRODUCTION AND EXPORT OF FRUITS

SHRI N. REDDEPPA:

Will the Minister of AGRICULTURE AND FARMERS WELFARE कृषि और किसान कल्याण मंत्री be pleased to state:

- (a) the details of production and exports of fruits during the last three years, State-wise;
- (b) whether the Government has taken any steps to provide financial and other assistance to the States for enhancing production and exports of fruits; and
- (c) if so, the details thereof and if not, the reasons therefor?

ANSWER

THE MINISTER OF AGRICULTURE AND FARMERS WELFARE

कृषि और किसान कल्याण मंत्री (SHRI NARENDRA SINGH TOMAR)

(a) The State-wise annual production of fruits for the last three years are given in Annexure-1 and the State of Origin-wise export of fresh fruits for the last three years are given in Annexure-2.

(b) Yes, Sir.

(c) The Mission for Integrated Development of Horticulture (MIDH), a Centrally Sponsored Scheme, is being implemented w.e.f. 2014-15 for holistic growth of the horticulture sector including fruits, covering all States and UTs. The Mission envisages production and productivity improvement of horticulture crops including fruits through various interventions. Activities such as production of planting material, coverage of area with improved cultivars, rejuvenation of senile orchards, protected cultivation, creation of water

resources, adoption of Integrated Pest Management (IPM), Integrated Nutrient Management (INM), organic farming, including insitu generation of organic inputs are taken up under MIDH. Capacity building of farmers and technicians are also provided for adopting improved technologies. The Scheme also envisages creation of Post-Harvest Management (PHM) and marketing for better price realization of produce.

Promotion of exports of agricultural products is an ongoing process. To promote agricultural exports, including of fruits, the Government has introduced a comprehensive Agriculture Export Policy, which is under implementation in collaboration with the States/UTs.

In addition, Agricultural & Processed Food Products Export Development Authority (APEDA) provides financial and other assistance to exporters of agriculture products including fruits under its various schemes and programmes as detailed under:

(i) **Agriculture and Processed Foods Export Promotion Scheme:** Financial assistance is provided under this scheme in three broad areas namely (i) Scheme for infrastructure Development, (ii) Scheme for Quality Development and (iii) Scheme for Market Promotion.

(ii) **Development of Common Infrastructure for agri exports:** APEDA provided financial assistance for setting up of common infrastructure facilities such as pack-houses, processing units, reefer van, etc. in various States across the Country.

(iii) **Sensitisation/ Capacity Building/ Training programmes:** Series of Capacity Building/training programmes have been carried out in Agri Clusters and States in association with the State Departments, SAUs, KVKs for the FPOs/FPCs/SHGs/Exporters in order to provide linkage of the Farmer groups to exports and to promote the entrepreneurs for becoming prospective exporters.

(iv) **e-Governance System:** To facilitate exports and strengthen the backward linkage, APEDA has implemented Traceability system such as HortiNet for potential fruits and vegetables and mangoes primarily for export to EU countries.

(v) **Collaboration with Missions/ Embassies:** APEDA has been regularly interacting with the Indian Missions abroad which enabled to tap the opportunities in the importing country's requirements arising on account of the COVID pandemic by organizing Virtual Trade Fairs (VTFs), Virtual Buyer Seller Meets and Export Promotion of GI Products
