PM-KISAN BENEFICIARIES IN JHARKHAND

267. SHRI JAYANT SINHA:

Will the Minister of AGRICULTURE AND FARMERS WELFARE कृषि एवं किसान कल्याण मंत्री be pleased to state:

- (a) the number of beneficiaries under the Pradhan Mantri Kisan Samman Nidhi (PM-KISAN) Yojana, Statewise;
- (b) the number of beneficiaries under PM-KISAN Yojana in Jharkhand, district-wise; and
- (c) the outreach and promotion initiatives of the Government to ensure the integration of all eligible farmers in the scheme?

ANSWER

- (a) The State-wise details of number of eligible beneficiaries under the Pradhan Mantri Kisan Samman Nidhi (PM-KISAN) Yojana since inception of the Scheme up to 12/07/2022 is attached at Annexure-1.
- (b) The District-wise details of number of eligible beneficiaries under the Pradhan Mantri Kisan Samman Nidhi (PM-KISAN) Yojana in the State of Jharkhand since inception of the Scheme up to 12/07/2022 is attached at Annexure-2.
- (c) Since the inception of the Scheme, the Government has undertaken various outreach and promotion initiatives to ensure that all eligible farmers are enrolled under the PM-KISAN Scheme. Government has set up a Project Monitoring Unit (PMU) at the central level which is entrusted with the responsibility of ensuring uploading of required data by the States / UTs on PM-KISAN portal, timely fund transfer to the beneficiaries, continuous review and monitoring of the scheme, publicity (Information, Education and Communication-IEC) campaign, incentive to field functionaries, etc. Government has also encouraged States/UTs to set up

their own PMUs as well for which administrative expenditure funds are released by the Government of India to respective States/UTs. Many campaigns have been organized at ground level by the respective State Governments on the direction of the Union Government to register all the eligible farmers under the Scheme.

Further, to achieve 100% saturation, a special facility has been provided to the farmers in the PM-KISAN portal, namely, 'Farmers Corner'. Through this facility, the farmers can also do their self-registration in the portal. Farmers can also edit their names in PM-KISAN database as per their Aadhaar database / card through the 'Farmers Corner' in the portal. Farmers can also know the status of their payment through the 'Farmers Corner' in the portal. The Common Service Centres (CSCs) have also been authorized to do registration of the farmers for the Scheme upon payment of fees. The above facilities on 'Farmers Corner' are also available through CSCs. A special Mobile App has also been launched on 24th February, 2020 on the 1st anniversary of the successful implementation of scheme. The App provides the facilities available through 'Farmers Corner'.
