Will the Minister of FISHERIES, ANIMAL HUSBANDRY AND DAIRYING मत्स्यपालन, पशुपालनऔरडेयरीमंत्री be pleased to state:

- a) whether the Government has introduced Pasu Kisan Credit Card scheme and if so, the details thereof;
- b) the date on which the said scheme has been implemented; and
- c) the details of the achievements made under the scheme during the current year, State-wise?

ANSWER

THE MINISTER OF FISHERIES, ANIMAL HUSBANDRY AND DAIRYING (SHRI PARSHOTTAM RUPALA)

- (a) & (b) Yes, Sir, the Reserve Bank of India (RBI) vide its circular FIDD.CO.FSD. BC.12/05.05.010/2018-19 dated February 04, 2019 has extended the Kisan Credit Card Scheme (KCC) facility to farmers engaged in animal husbandry and fisheries for their working capital requirement. The KCC facility will meet the short-term credit requirement of rearing of animals, birds, fish, shrimp, other aquatic organisms, capture of fish. Under KCC scheme, loan up to Rs 1.60 lakh is collateral free.
- (c) State/UT wise details of KCC sanctioned to animal husbandry, dairy and fisheries farmers during the current year (2022-23) as on 22.07.2022 are given at Annexure.
