RURAL LIVELIHOOD TRAINING CENTRES

2706. DR. T. SUMATHY (a) THAMIZHACHI THANGAPANDIAN:

Will the Minister of RURAL DEVELOPMENT be pleased to state:

- (a) whether the Government has any plans to establish Rural Livelihood Training Centres in Tamil Nadu;
- (b) if so, the details thereof and if not, the reasons therefor;
- (c) whether the Government has allocated funds to Tamil Nadu to implement various schemes under the local bodies and village/rural administration; and
- (d) if so, the details thereof?

ANSWER

(a) & (b) Various training centers are imparting Rural Livelihoods training in State of Tamil Nadu. The details of training centers are as under:

i) Rural Self Employment Training Institutes (RSETI), conduct various kinds of skill trainings including Rural Livelihood in rural areas, managed by lead Bank of the district. Total 33 RSETIs are providing trainings for promoting Rural Livelihoods.

(ii) Community Managed Training Centres (CMTCs): A total number of 5 CMTCs are operational and are being utilized for providing trainings on Rural Livelihoods also.

iii) A total of 30 Kisan Vikas Kendras of Agriculture Department are being utilized for providing training related to agriculture and agri-allied activities.

(c) & (d) Yes Sir. Government of India allocated funds to Tamil Nadu to implement various schemes in the rural areas. The details of funds allocated/release under different schemes of the Ministry are as under:
