ALTERNATIVES FOR TOBACCO FARMERS

2729. DR. (PROF.) KIRIT PREMJIBHAI SOLANKI: SHRI M. SELVARAJ:

Will the Minister of AGRICULTURE AND FARMERS WELFARE कृषि एवं किसान कल्याण मंत्री be pleased to state:

- a) whether there is any development scheme for promoting tobacco crop alternatives for tobacco farmers currently;
- b) if so, the budget allocated for the same for the last five years including the States covered;
- c) the details of the acres of land shifted from tobacco farming and these alternative crops; and
- d) the details of the kind of institutional, monetary and regulatory support given by various Ministries of the Central and State Governments for the tobacco farmers for alternate cropping and/ or for alternate livelihood?

ANSWER

MINISTER OF AGRICULTURE AND FARMERS WELFARE

(a) The Department of Agriculture & Farmers Welfare (DA&FW) has been implementing Crop Diversification Programme (CDP), a sub-scheme of Rashtriya Krishi Vikas Yojana (RKVY), in 10 tobacco growing states of Andhra Pradesh, Bihar, Gujarat, Karnataka, Maharashtra, Odisha, Tamil Nadu, Telangana, Uttar Pradesh and West Bengal to encourage farmers to shift to alternative crops/cropping system since 2015-16. Under CDP, tobacco growing states have been given the flexibility to take suitable activities / interventions to shift from tobacco crops to alternative agricultural / horticultural crops.

- (b) For implementation of the scheme in 10 tobacco growing states namely Andhra Pradesh, Bihar, Gujarat, Karnataka, Maharashtra, Odisha, Tamil Nadu, Telangana, Uttar Pradesh and West Bengal, the central share of Rs. 667.00 lakh, 667.00 lakh, 667.00 lakh, 1000.00 lakh and 1000.00 lakh were allocated during the year 2017-18, 2018-19, 2019-20, 2020-21 and 2021-22, respectively.
- (c) A total of 111889 acres land has been shifted from tobacco farming during last five years i.e. 2017-18 to 2021-22 to other alternative crops/cropping system.
- (d) In addition to CDP, the Government of India is also providing flexibility to the states for state specific needs/priorities under RKVY and the States can promote crop diversification under RKVY with the approval of State Level Sanctioning Committee (SLSC) headed by Chief Secretary of the respective states. The DA&FW also implement various crop development programmes such as the National Food Security Mission on Rice, Wheat, Pulses, Nutri Cereals, Coarse Cereals, Oilseeds and Commercial Crops (Cotton, Jute & Sugarcane), Mission for Integrated Development of Horticulture (MIDH) etc. for promotion of agricultural / horticultural crops.

ICAR- Central Tobacco Research Institute, Rajahmundry has recommended alternative cropping system to the states for replacing tobacco.
