PMFME SCHEME FOR MICRO ENTERPRISES

2754. SHRI P RAVINDHRANATH:

Will the Minister of *FOOD PROCESSING INDUSTRIES* be pleased to state:

- (a) whether the Government has launched Pradhan Mantri Formalisation of micro food processing enterprises (PMFME) Scheme to empower the unorganized Micro Enterprises in food processing sector;
- (b) if so, whether the Government has invited registration from the food processing industry for credit linked subsidy through specific portal under this scheme;
- (c) if so, the details thereof and the total number of registrations done, State-wise including the State of Tamil Nadu; and
- (d) the details of financial implications since the inception of this schemes?

ANSWER

THE MINISTER OF STATE FOR FOOD PROCESSING INDUSTRIES (SHRI PRAHLAD SINGH PATEL)

- (a): Yes, Sir. Ministry of Food Processing Industries (MoFPI) is implementing a centrally sponsored "PM Formalisation of Micro food processing Enterprises (PMFME) Scheme" for providing financial, technical and business support for setting up / upgradation of micro food processing enterprises in the country. The scheme aims to enhance the competitiveness of existing individual microenterprises in the unorganized segment of the food processing industry and promote formalization of the sector.
- (b) & (c): Yes, Sir. A total of 51,792 registrations by individual micro food processing enterprises have been done on PMFME portal till 20. 07. 2022. State-wise details of registrations including the State of Tamil Nadu are at **Annexure.**
- (d): The PMFME scheme has been approved for a period of five years from 2020-21 to 2024-25 with an outlay of Rs. 10,000 Crore. Out of which, an amount of Rs. 742.72 crore has been released so far.
