Will the Minister of RAILWAYS be pleased to state:

- (a) whether the Government has installed Integrated Security System (ISS) at all the identified sensitive railway stations in the country;**
- (b) if so, the details thereof as on date and if not, the reasons therefor along with the number of sensitive railway stations in the country;**
- (c) the number of complaints received by the Government for inadequate security to the passengers on such stations during each of the last three years and the current year along with the present status of such complaints, Zone-wise;**
- (d) the details of the funds sanctioned and utilized for installation of ISS at such stations during the said period, Zone-wise;**
- (e) whether the Government has received suggestions from various quarters to improve security at such stations; and**
- (f) if so, the details thereof, Zone-wise along with the action taken/being taken by the Government on such suggestions so far?**

(a) and (b): With a view to strengthen surveillance mechanism at sensitive railway stations, installation of an Integrated Security System (ISS) was initially approved for 202 identified stations comprising of Close Circuit Television (CCTV) surveillance system, access control, personal and baggage screening system and bomb detection system. CCTV cameras have been provided over 196 railway stations under ISS. Reassessing the requirements and vulnerability, the total number of stations under ISS has been reduced to 199 stations. In addition, 194 baggage scanners, 69 under vehicle scanning system (UVSS) and 129 bomb detection items have also been provided under ISS, 422 dogs have also been deployed over different zonal railway for detection of explosives and tracking purposes.

(c): 22 complaints for inadequate security have been received on such stations during last three years. Prompt action was taken on all these complaints on their receipt in coordination with Government Railway Police (GRP).

(d): Fund sanctioned and incurred by the Railways are ₹ 341.00 Crore and ₹ 322.18 Crore respectively. The zone-wise details are appended.

(e) and (f): Suggestions are being received regularly. Receipt and consideration of suggestion to improve security of stations is an ongoing process. The suggestions received are considered duly examining it for its implementation.
