280. MS. MIMI CHAKRABORTY:

Will the Minister of RURAL DEVELOPMENT be pleased to state:

- (a) the details of total length of roads sanctioned and constructed in West Bengal under Pradhan Mantri Gram Sadak Yojana (PMGSY) since 2019-20;
- (b) total number of pending projects with the Union Government for West Bengal under PMGSY and the time by which the said proposals are likely to be sanctioned;
- (c) the detail of projects sanctioned and pending under PMGSY since 2019-20, Statewise; and
- (d) the measures taken to ensure the release of funds to the States under PMGSY without any further delay?

ANSWER

MINISTER OF STATE IN THE MINISTRY OF RURAL DEVELOPMENT (SADHVI NIRANJAN JYOTI)

(a) The details of road length sanctioned and constructed in the State of West Bengal under Pradhan Mantri Gram Sadak Yojna (PMGSY) since 2019-20 are given below:-

(b) The State of West Bengal has been allocated a target of 6,288 Km of road length under PMGSY-III. Out of which, the proposal for 363 roads of length 2,251.69 Km was submitted by the State Government which was put before the Empowered Committee meeting held on 28.05.2022. The compliance report of the observations made during the meeting has been received from the State Government on 12.07.2022 which is being examined as per the programme guidelines.

(c) The state-wise details of projects sanctioned under PMGSY since 2019-20 is given at **Annexure-I.** Currently, projects are being sanctioned under PMGSY-III. Target, sanctioned and balance road length to be sanctioned under PMGSY-III are given in **Annexure-II.** The Ministry is pursuing with States to submit proposals for balance targets. The timeline for completion of PMGSY-III is March, 2025.

(d) The release of central funds to the State for implementation of PMGSY is done on the basis of the proposal received from the state and depends, inter-alia, on works in hand, execution capacity of the State and unspent funds available with the State. As per the information available on programme Management Information System (MIS), as on 13.07.2022, the State of West Bengal has an unspent balance of Rs. 278.17 crore (excluding Security Deposits)
