Will the Minister of CONSUMER AFFAIRS, FOOD AND PUBLIC DISTRIBUTION उपभोक्ता मामले. खाद्य और सार्वजनिक वितरण मंत्री be pleased to state:

- (a) the details of food subsidy released to States/ UTs during the year 2020-21;
- (b) the year-wise details of food subsidy released to Gujarat under decentralised procurement system during the last three years; and
- (c) whether the Government proposes to issue food coupons to every BPL household who can get foodgrains through these coupons in place of cash at public distribution shops in order to make the public distribution system more effective?

ANSWER

MINISTER OF STATE FOR MINISTRY OF RURAL DEVELOPMENT AND CONSUMER AFFAIRS, FOOD & PUBLIC DISTRIBUTION (SADHVI NIRANJAN JYOTI)

(a): Department of Food and Public Distribution (DFPD), Government of India deals with the release of food subsidy to Food Corporation of India (FCI) and States which have adopted Decentralized Procurement (DCP). States are allocated foodgrains at subsidized rates under National Food Security Act, 2013 (NFSA) and Other Welfare Schemes (OWS). Difference between Economic Cost and Central Issue Price (CIP), at which foodgrains are issued to States, is reimbursed to FCI as food subsidy. In case of DCP States, food subsidy is directly released to States by Government of India for quantity of foodgrains procured and distributed by them under NFSA and Other Welfare Schemes. FCI further releases funds to Non-DCP States for quantum of foodgrains received by FCI from Non-DCP States. The subsidy is provided to DCP States and FCI, which is the instrument of the Government of India for procurement and distribution of wheat and rice under NFSA and Other Welfare Schemes and for maintaining the buffer stock of foodgrains as a measure of food security.

Details of food subsidy released to States/UT during the year 2020-21 is enclosed at Annexure-I.

- (b): Details of food subsidy released to the Gujarat under decentralized procurement system during the last three years is enclosed at Annexure-II.
- (c): No such proposal is presently under consideration.
