- (a) whether the National Industrial Development Corridor Corporation (NICDC) is presently executing a number of corridors/projects in various cities in the country;
- (b) if so, the details thereof, State-wise and the progress made so far, project-wise;
- (c) whether huge delay in the acquisition and allotment of lands has resulted in cost and time overrun;
- (d) if so, the details of remedial action taken by the Government in this regard; and
- (e) if not, the reasons therefor?

- (a) to (e):** Government of India has identified 11 Industrial corridors having 32 projects/ nodes/ integrated manufacturing clusters. The execution of projects depend on factors like signing of State Support Agreement (SSA), Share Holders Agreement (SHA), making land parcel available etc. by respective State Government. The details of all industrial corridors are given at **Annexure**.

As per the approved institutional and financial framework, Government of India provides funds as equity/debt for development of world class trunk infrastructure, the States are responsible for making available contiguous parcels of land for the project.

Approval of project and its implementation can be taken up only after substantial portion of land has been acquired by state and handed over for the project. Delay in acquisition of land results in delayed implementation. System of regular review and coordination meetings with states is under practice.
