Will the Minister of JAL SHAKTI be pleased to state:

- (a) whether the work is being carried out under Har Ghar Jal/Nal se Jal under Jal Jeevan Mission (JJM) Scheme in Shahjahanpur and Prayagraj districts of Uttar Pradesh;
- (b) if so, the details thereof along with the current status and the cost of the project;
- (c) the names of institutions to which the work under Nal se Jal Yojana have been assigned;
- (d) the details of funds allocated for the said scheme, year-wise since 2019;
- (e) whether the Government has received complaints from public representatives in June, 2022 about the development/quality of works being done under the said scheme in the above mentioned districts; and
- (f) if so, the details thereof along with the action taken by the Government in this regard?

ANSWER

THE MINISTER OF STATE FOR JAL SHAKTI (SHRI PRAHLAD SINGH PATEL)

(a) to (d) Jal Jeevan Mission (JJM), a centrally sponsored scheme, is being implemented in partnership with States, since August, 2019 to make provision of potable tap water supply to every rural household of the country, including those in the Shahjahanpur and Prayagraj districts of Uttar Pradesh, by 2024.

Drinking Water being a State subject, it is States, who plan, design, approve and implement drinking water supply schemes. Government of India supplements the efforts of the States by providing technical and financial assistance. As such details of individual projects/ schemes for rural water supply projects including water source for scheme are not maintained at the Government of India level.

However, as informed by the State of Uttar Pradesh, in Shahjahanpur, works in 383 schemes covering 733 revenue villages amounting to Rs. 2,342.52 Crore and in Prayagraj, in 348 schemes covering 598 revenue villages amounting to Rs. 1,173.95 Crore have been sanctioned under JJM and works are in progress. Further, M/s Nagarjun Construction Company Ltd. (NCC Ltd.) and M/s Larsen & Tourbo Company Ltd. are working in Shahjahanpur and Prayagraj districts respectively.

Details of fund allocated to Shahjahanpur and Prayagraj districts of Uttar Pradesh under Jal Jeevan Mission in 2019-20, 2020-21, 2021-22 and 2022-23 (as on 01.08.2022) as reported by the State is as under:

(e) & (f) Grievances received at Centre level through Centralized Public Grievance Redress and Monitoring System (CPGRAMS -https://pgportal.gov.in/) and Department's website (https://jalshakti-ddws.gov.in/) and other physical mediums are transferred to water supply department of respective State Governments for their timely redressal. Further, State has also informed that State Water & Sanitation Mission has not received any complaint from any public representatives in the month of June, 2022 for Shahjahanpur & Prayagraj districts.
