- (a): Details of applications received seeking assistance for setting up/expansion of Food Processing Industries in Rajasthan state under component schemes of Pradhan Mantri Kisan SAMPADA Yojana (PMKSY) and Production Linked Incentive Scheme for Food Processing Industry (PLISFPI) through respective on-line portals is placed at **Annexure-I.**
- (b): Details of projects approved under PMKSY and PLISFPI in Rajasthan is placed at **Annexure-II.**
- (c): Being central sector scheme, no state-wise budget allocation is done under PMKSY & PLISFPI. Year-wise details of total allocation and fund utilized under these schemes since 2019-20 is placed at **Annexure-III.**
- (d): Grants-in-aid @ 35 % of eligible project cost is provided for general areas for setting up of Food Processing Industries under component schemes of PMKSY, as per current scheme guidelines. Special incentive is admissible for projects approved for SC/ST entrepreneurs / North eastern Region and other difficult and hilly areas.
