- (d) if so, the details thereof; and
- (e) the details of the number of projects approved for setting up/expansion of food processing industries in the country, year-wise?

### ANSWER

# THE MINISTER OF STATE FOR FOOD PROCESSING INDUSTRIES (SHRI PRAHLAD SINGH PATEL)

(a) & (b): Yes, sir. Ministry of Food Processing Industries (MoFPI) has been incentivizing setting up/ expansion of Food Processing Industries through its Central Sector Umbrella Scheme Pradhan Mantri Kisan SAMPADA Yojana (PMKSY), Production Linked Incentive Scheme for Food Processing Industry (PLISFPI) and Centrally sponsored PM Formalization of Micro Food Processing Enterprises (PMFME) scheme across all the states including Bihar. The details of projects approved under these schemes in Bihar including in Gopalganj district since 2019-20 is placed at **Annexure-I.** 

(c) & (d): No Sir, MoFPI has not transferred ownership of any public sector unit to private sector during last 3 years.

(e): Year-wise details of the number of projects approved for setting up/expansion of food processing industries under component schemes of PMKSY is placed at **Annexure-II.**
