CRIME AGAINST CHILDREN IN ORPHANAGES

3378. MS. CHANDRANI MURMU: SHRIMATI VANGA GEETHA VISWANATH:

Will the Minister of WOMEN AND CHILD DEVELOPMENT be pleased to state :

- (a) the details of incidents of crimes against children across the country during the last three years, State/UT-wise;
- (b) whether the Ministry is aware that many cases of crimes against children are recorded in children homes and orphanages of the country, if so, the details thereof;
- (c) whether audits and reviews of the children homes and orphanages have been carried out/done at regular interval in various States, including Odisha, if so, the details and the outcome thereof; and
- (d) whether the Government has received any report of atrocities committed on the children in such homes in Odisha and if so, the details thereof along with action taken thereon, district-wise?

ANSWER

MINISTER OF WOMEN AND CHILD DEVELOPMENT (SHRIMATI SMRITI ZUBIN IRANI)

(a) : As per information provided by the National Crime Records Bureau, State/UT-wise details of incidents of crimes against children across the country during the last three years is at Annexure-I.

(b) : As per information provided by the National Commission for Protection of Child Rights (NCPCR), 34 complaints were received relating to child abuse/exploitation in the Child Care Institutions (CCIs) including orphanages during the last three years.

(c) : As per information provided by the National Commission for Protection of Child Rights (NCPCR), social audit of Child Care Institutions (CCIs) was conducted across the country including Odisha in compliance of the Hon'ble Supreme Court's order dated 05.05.2017 in the matter of W.P. (Crl.) 102 of 2007 in Re. Exploitation of children in orphanages in State of Tamil Nadu Vs. Union of India. A National Report as well as State Reports of social audit was submitted to the Hon'ble Supreme Court on 06.03.2020. These reports and deficiencies found during the social audit in each CCI were also provided to respective District Magistrates alongwith the copy to Principal Secretary, Department of Women and Child Development (of respective State Governments) for their necessary action.

(d) : As per information provided by the NCPCR, a complaint of sexual abuse of child in children home run by Faith Outreach NGO, by its founder in Jharsuguda district of Odisha was received in the Commission in 2020-21. The Commission raised its concerns and forwarded recommendations to Principal Secretary, Women and Child Development Department, Odisha.

Another complaint of sexual abuse of children in children home namely "Proud", Paralakhemundi, Gajapati district, Odisha by Secretary of the home was received in the Commission in 2021-22. Considering the seriousness of the case, the Commission issued summon/notice to District Magistrate and Superintendent of Police, Gajapati. The district administration submitted in its report that First Information Report was registered under appropriate sections of rape in Indian Penal Code and sections of Protection of Children from Sexual Offences Act, 2012 were also imposed. Legal action against District Child Protection Officer, Gajapati was also taken in the matter.
