Herbal Gardens by NMPB

3381. SHRIMATI VANGA GEETHA VISWANATH:

Will the Minister of **AYUSH** be pleased to state:

- (a) the details of funds allocated to establishing herbal gardens by the National Medicinal Plants Board in the last five years;
- (b) the details of the herbal garden projects supported across the country under the scheme during each of the last five years, State-wise; and
- (c) the details of funds sanctioned and allocated for the projects for the said time period?

**ANSWER

(a) to (c): Presently, the 'National Medicinal Plants Board', Ministry of AYUSH is implementing a "Central Sector Scheme on Conservation, Development and Sustainable Management of Medicinal Plants" throughout the country under which there is a provision to provide project based support to various Government and Non-Government organizations to develop different types of Herbal Gardens viz. Home Herbal Gardens, School Herbal Gardens, Institutional/ Public Herbal Gardens and Herbal Gardens of State and National importance. NMPB has sanctioned 81 projects of total sanctioned amount of Rs.3145.86 Lakhs. The details of projects along with funds sanctioned for establishing herbal gardens by the National Medicinal Plants Board in the last five years are placed at **Annexure - I**.
