#### CONSTRUCTION OF ANGANWADI CENTRES UNDER MGNREGS

#### 341. SHRI JUAL ORAM:

Will the Minister of RURAL DEVELOPMENT be pleased to state:

- (a) whether construction of Anganwadi centres under Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS) is permissible;
- (b) if so, the number of Anganwadi centres constructed under MGNREGS in Odisha during each of the last five years and the current year, district-wise; and
- (c) the number of Anganwadi centres that the Government is planning to construct under MGNREGS during the current year and during 2022-23 in Odisha, district-wise?

#### **ANSWER**

### MINISTER OF STATE IN THE MINISTRY OF RURAL DEVELOPMENT (SADHVI NIRANJAN JYOTI)

- (a): As per Para 4 (I) of Schedule–I of the Mahatma Gandhi National Rural Employment Guarantee Act (Mahatma Gandhi NREGA), construction of buildings for Anganwadi Centres at the village level or block level is permissible under Mahatma Gandhi National Rural Employment Guarantee Scheme (Mahatma Gandhi NREGS).
- (b) Year-wise and district-wise details of Anganwadi Centers constructed under Mahatma Gandhi NREGS in the State of Odisha during the last five financial years 2017-18, 2018-19, 2019-20, 2020-21, 2021-22 and current financial year 2022-23 (as on 13.07.2022) is given at **Annexure.**
- (c): Mahatma Gandhi National Rural Employment Guarantee Scheme (Mahatma Gandhi NREGS) is demand driven wage employment programme with bottom up planning. The Ministry does not plan or set any target for any specific work (including Anganwadi Centres) under the Scheme for any States/Uts. The Gram Panchayat is responsible for identification of works in the Gram Panchayat area to be taken under the Scheme as per recommendations of the Gram Sabha, and for executing and supervising such works.
