# **BOOSTER DOSE OF COVID VACCINE**

#### 3410. SHRI RAKESH SINGH:

Will the Minister of **HEALTH AND FAMILY WELFARE** be pleased to state:

- (a) whether the booster dose of COVID vaccine is being administered free of cost to the people in the age group of 18 to 59 years in the country; if so, the details thereof;
- (b) whether the number of people taking booster dose has increased as a results of the said initiative;
- (c) if so, the details thereof;
- (d) whether the booster dose of the vaccine has been kept free of cost for a limited period of time, if so, the details thereof;
- (e) whether the Government has made arrangement for availability of sufficient number of vaccine doses to cover all the eligible beneficiaries; and
- (f) if so, the details thereof, State/UT-wise particularly district-wise in Madhya Pradesh?

#### ANSWER

# THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (DR. BHARATI PRAVIN PAWAR)

(a) to (f): Starting from 15th July 2022, under the "Covid Vaccination Amrit Mahotsava" initiative, precaution dose is available free of cost for 75 days (i.e.  $30^{th}$  September 2022), to all beneficiaries  $\geq 18$  years of age at all Government Covid Vaccination Centers (CVCs) after an interval of 6 months from the date of administration of the  $2^{nd}$  dose.

Administration of precaution dose began from 10<sup>th</sup> January 2022, and till 15<sup>th</sup> July 2022 a total of 5.26 crore precaution doses were administered with a daily average of 2.83 Lakh precaution doses administered whereas from 15<sup>th</sup> July 2022 under "Covid Vaccination Amrit Mahotsava" a total of 3.8 crore precaution doses are administered with a daily average of 25.33 Lakh vaccine doses. Adequate Covid-19 vaccine doses are made available to all States/UTs to vaccinate all eligible beneficiaries with precaution dose. District wise distribution of vaccine is done from State. State/UT wise vaccines supplied in the Covid-19 vaccination programme as on 1<sup>st</sup> August 2022, is at annexure-1.
