ALLOCATION OF FUNDS UNDER RIDF

Will the Minister of FINANCE be pleased to state:

- (a) the details of the programmes being implemented for rural infrastructure development in the country;
- (b) whether the funds have been allocated by the Union Government to the States under Rural Infrastructure Development Fund (RIDF);
- (c) if so, the details thereof including the funds allocated for training and other services/works for development of rural infrastructure during the last three years and the current year, State-wise including Bihar and Chhattisgarh; and
- (d) the steps taken by the Government for proper implementation of the Centrally sponsored rural development schemes in the country?

Answer

THE MINISTER OF STATE IN THE MINISTRY OF FINANCE
(DR. BHAGWAT KARAD)

(a): The Ministry of Rural Development (MoRD) is implementing a number of welfare schemes in rural areas for bringing an overall improvement in the quality of life of the people, strengthening livelihood opportunities, promoting self-employment, development of infrastructure etc. These include Mahatma Gandhi National Rural Employment Guarantee Scheme (Mahatma Gandhi NREGS), Pradhan Mantri Awaas Yojana – Gramin (PMAY-G), Pradhan Mantri Gram Sadak Yojana (PMGSY), Deendayal Antyodaya Yojana – National Rural Livelihoods Mission (DAY-NRLM), Deen Dayal Upadhyay – Gramin Kaushalya Yojana (DDU-GKY) etc.

In addition, National Bank for Agriculture and Rural Development (NABARD) is implementing various schemes for development of critical infrastructure in rural areas under various funds, such as, Rural Infrastructure Development Fund (RIDF), Long Term Irrigation Fund (LTIF), Micro Irrigation Fund (MIF), Dairy processing and Infrastructure Fund (DIDF), Fisheries and Aquaculture Infrastructure Fund (FIDF).

(b) & (c): Based on the recommendation of the Govt., RBI makes annual allocation of funds to NABARD for RIDF. NABARD, in turn, allocates funds to the States. State-wise details of the funds sanctioned under RIDF during the last three years (including Bihar and Chhattisgarh) are annexed.

(d): The progress under schemes implemented by MoRD is being regularly reviewed by way of Regional Review Meetings (RRMs), Performance Review Committee (PRC) Meetings & Pre-Empowered/Empowered Committee Meetings with the States. In addition to this, special review meetings/monthly review meetings are also held at different levels in the MoRD with State Governments. The representatives from the Ministry also visit States and provide on-site guidance to the State/UT representatives for speedy implementation of the schemes.

Under RIDF, the State Governments have their own mechanism for monitoring of projects, which includes monitoring by their Engineers/Officers including that of Quality Control Wing, etc. The monitoring of RIDF projects by NABARD is conducted through Desk Monitoring (off-site), and Field Monitoring (on-site).
