Will the Minister of FINANCE be pleased to state:

- (a) the details of the status of the 45 warehouse projects sanctioned under the Warehouse Infrastructure Fund for Andhra Pradesh;
- (b) whether the warehouse projects sanctioned for Avanigadda, Kanchkacherla, Nandigama, Vuyyuru in Krishna district have been withdrawn;
- (c) if so, the reasons therefor, project-wise;
- (d) the details of the procedure to get the projects re-sanctioned, if the project prerequisite conditions are met; and
- (e) the details of non-operational, dilapidated/end-of-line godowns in Krishna district?

Answer

THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (DR. BHAGWAT KARAD)

(a) to (e): As apprised by National Bank for Agriculture and Rural Development (NABARD), the status of the 45 warehouse projects sanctioned under the Warehouse Infrastructure Fund (WIF) for Andhra Pradesh is annexed.

NABARD has further informed that the warehouse projects sanctioned for Avanigadda, Kanchkacherla, Nandigama, Vuyyuru in Krishna district have been withdrawn due to unavailability of land at the proposed locations. As the entire corpus under WIF has been fully committed for different warehouse projects across the country, no fresh projects (either new or withdrawn) can be taken up for sanction.

As apprised by Department of Food and Public Distribution, there are no non-operational, dilapidated/end-of life godowns in Krishna district under Food Corporation of India (FCI) and Central Warehousing Corporation (CWC), Andhra Pradesh Region.
