## FOREST LAND ALLOTTED TO TRIBAL PEOPLE

## †3510. SHRI ASHOK MAHADEORAO NETE:

Will the Minister of TRIBAL AFFAIRS be pleased to state:

- (a) whether tribal people in the tribal dominated areas of the country have been allocated forest land for agricultural produce to help them earn their livelihood;
- (b) if so, the number of such tribal people who have been allocated forest land till date in tribal dominated areas, particularly in Maharashtra during the last three years;
- (c) whether the Government has formulated/proposed to formulate any programme for making provision of water to irrigate the forest land allocated to these tribal farmers; and
- (d) if so, the details thereof and if not, the reasons therefor?

#### **ANSWER**

# MINISTER OF STATE FOR TRIBAL AFFAIRS (SHRI BISHWESWAR TUDU)

- (a) & (b): Under the provisions of 'the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 (in short FRA) rights are recognized and vested to the eligible individuals and community from amongst Scheduled Tribes and Other Traditional Forest Dwellers to use forest land and resources for their livelihood through the respective State Governments / UT Administrations. As per the information received from State Governments a total of 44,29,065 claims (42,60,247 individual and 1,68,818 community claims) have been filed and 22,34,292 titles (21,32,217 individual and 1,02,075 community claims) have been distributed to the extent of 1,59,12,693 acres of forest land (45,47,165 acres individual and 1,13,65,528 acres community) upto 31.03.2022. The State-wise details of number of claims received (individual and community), number of titles distributed (individual and community) and extent of forest land for which titles distributed (individual and community) upto 31.03.2022 is at Annexure.
- (c) & (d): Ministry of Tribal Affairs is not implementing any specific scheme for irrigation of the forest land allocated to tribal farmers under FRA. However, the forest land for which titles have been distributed is also covered under different agriculture/irrigation programmes/schemes implemented by Central and State Governments. Dedicated funds have been allocated as Scheduled Tribe Component (STC) under the schemes of irrigation implemented by various Central Ministries, which inter-alia includes funds allocated during 2022-23 as under:
