Will the Minister of LABOUR AND EMPLOYMENT be pleased to state:

- (a) the salient features and process of registration on the e-Shram portal and the nodal authorities responsible for the registration process;**
- (b) the State-wise percentage of targeted number of registrations achieved till date along with district-wise details for Andhra Pradesh;**
- (c) the details of targeted number of registrations decided for each State;**
- (d) the State-wise number of unorganised workers registered on the said portal including Maharashtra and Ajmer, Jaipur and Nagaur of Rajasthan;**
- (e) whether the Government has launched the said portal to create national Databases of unorganised workers which has been linked to AADHAAR, if so, the details thereof and the eligibility criteria fixed in this regard;**
- (f) the State-wise and district-wise total number of workers registered so far including Maharashtra and the details of the challenges being faced by the Government to register unorganised workers on the said portal; and**
- (g) whether the Government has formulated any scheme to provide financial assistance and other benefits to the workers registered on the said portal and if so, the details thereof?**

**MINISTER OF STATE FOR LABOUR AND EMPLOYMENT
(SHRI RAMESWAR TELI)**

(a) to (g): On 26.08.2021 Ministry of Labour & Employment has launched e-Shram portal to create a National Database of the Unorganised Workers with Aadhaar seeding. The total registration on e-Shram portal as on 30.07.2022 is more than 28 crore. One of the objectives of eShram portal is to facilitate delivery of social benefit schemes to the unorganised workers. Any unorganised worker aged between 16-59 years and not a member of Employees' State Insurance Corporation (ESIC)/ Employees' Provident Fund

Organisation (EPFO) and not an Income Tax payee, is eligible for registration on this portal. The workers can easily get themselves registered on the portal through following three modes:-

- (i) Self-registration**
- (ii) Through Common Service Centres (CSCs)**
- (iii) Through State Seva Kendras.**

As on 30.07.2022, state-wise estimated target of registration, number of unorganised workers registered on eShram portal and percentage of target achieved are at Annexure-I. The district wise registration on eShram portal in the State of Andhra Pradesh and Maharashtra is at Annexure-II. The registration in the district of Ajmer, Jaipur and Nagaur of Rajasthan is 4,76,047, 12,35,515 and 5,18,033 respectively.

A link for maandhan.in portal is provided on eShram portal to facilitate eShram registrants to register and get benefit of Pradhan Mantri Shram Yogi Maandhan Yojana (PM-SYM) and National Pension Scheme (NPS) Traders scheme.
