Will the Minister of TOURISM be pleased to state:

- (a) the major objectives and features of the Swadesh Darshan Scheme (SDS) along with the details of projects sanctioned under Eco Theme for Madhya Pradesh, Gujarat, Uttar Pradesh, Rajasthan and Odisha;
- (b) the Detailed Project Reports (DPRs) for ongoing major infrastructural development projects in Madhya Pradesh, Gujarat, Uttar Pradesh, Rajasthan and Odisha under SDS;
- (c) the details of funds allocated in 2022-23 for Madhya Pradesh, Gujarat, Uttar Pradesh, Rajasthan and Odisha under SDS for strengthening tourism infrastructure through various spiritual circuits;
- (d) the efforts made so far by the Government for the promotion of this scheme; and
- (e) the Foreign Exchange Earnings from tourism in Madhya Pradesh, Gujarat, Uttar Pradesh, Rajasthan and Odisha in million US dollars since 2019?

ANSWER

THE MINISTER OF TOURISM

(SHRI G. KISHAN REDDY)

(a): The Ministry of Tourism under its scheme of 'Swadesh Darshan' provides financial assistance to State Governments /Union Territory (UT) Administrations/Central Agencies etc. for development of tourism

infrastructure in the country. The projects under the scheme are sanctioned subject to availability of funds, submission of suitable Detailed Project Reports (DPR), adherence to scheme guidelines and utilization of funds released earlier etc. The details of projects sanctioned in the States of Madhya Pradesh, Gujarat, Uttar Pradesh, Rajasthan and Odisha under the scheme including their theme, amount sanctioned and amount released are annexed.

The Ministry of Tourism has now revamped its Swadesh Darshan scheme as Swadesh Darshan 2.0 (SD2.0) in order to develop sustainable and responsible destinations with tourist & destination centric approach. The objective of the scheme includes the following:

- a) To enhance the contribution of tourism to the local economies.
- b) To create jobs including self-employment for local communities.
- c) To enhance the skills of local youth in tourism and hospitality.
- d) To increase private sector investment in tourism and hospitality.
- e) To preserve and enhance the local cultural and natural resources.
- (b) to (d): The Ministry of Tourism has shared the scheme guidelines for SD2.0 with all the State Governments/UT Administrations and have apprised them of the scheme during multiple meetings including the states of Madhya Pradesh, Gujarat, Uttar Pradesh, Rajasthan and Odisha. As of now, no Detailed Project Report (DPR) has been received under SD2.0 scheme guidelines.
- (e): The data on State-wise Foreign Exchange Earnings (FEE) through Tourism is not maintained by the Ministry of Tourism. However, following FEE is earned during the year 2019 and 2020
