#### **SKILL TRAINING CENTRES**

3592: SHRI BHOLA SINGH: PROF. SOUGATA RAY:

Will the Minister of SKILL DEVELOPMENT AND ENTREPRENEURSHIP be pleased to state:

- (a) the details of skill training centres in the country, State/UT-wise including set up in Bulandshahar of Uttar Pradesh;
- (b) the details of youth who got skill training though such centres since the last three years in the country, State/UT-wise;
- (c) the number of youths among them who got permanent jobs/livelihood; and
- (d) whether the Government has any proposal to make the skill development is a mandatory qualification for jobs in future as also to involve private sector in this regard and if so, the details thereof; and
- (e) whether the Government has also made any arrangements for providing advanced training to trainers for ensuring the quality of training and if so, the details thereof?

### **ANSWER**

### MINISTER OF STATE IN THE MINISTRY OF SKILL DEVELOPMENT AND ENTREPRENEURSHIP (SHRI RAJEEV CHANDRASEKHAR)

- (a) Under Skill India Mission, the Ministry of Skill Development and Entrepreneurship (MSDE) has been delivering short term and long term skills through Pradhan Mantri Kaushal Vikas Yojana (PMKVY), Jan Shikshan Sansthan (JSS) Scheme, National Apprenticeship Promotion Scheme (NAPS) and Craftsman Training Scheme (CTS)/Industrial Training Institutes (ITIs), to all across the country. The details of skill training centres under these schemes in the country, State-wise are at **Annexure-I**. The details of training centres set up in Bulandshahar of Uttar Pradesh under these schemes are at **Annexure-II**.
- (b) The details of youth who got skill training through such centres since the last three years in the country, State-wise under PMKVY,JSS, NAPS and ITIs are at **Annexure-III**, **Annexure-IV**, **Annexure-V** and **Annexure-VI** respectively.
- (c) Amongst the schemes of the Ministry of Skill Development and Entrepreneurship, only in the case of the PMKVY, placement was mandatory. So, placement is not tracked in other schemes viz. JSS, NAPS and CTS/ITIs. However, third party evaluation reports have mentioned about success in terms of placement or increases in income of candidates trained under different schemes. The brief details of the same are as given below:

**PMKVY:** The number of youth placed across the country, State-wise; under PMKVY is attached at **Annexure VII**. As per the Third Party Evaluation Report on PMKVY 2.0 (2016-20), it was found

that average monthly income of PMKVY trained and certified individuals was 15% higher than the comparison group. Moreover, 76% of the candidates acknowledged that after the training, they have better chance of getting employment.

JSS: The objective of training imparted under JSS is to link the individuals for gain full livelihood and supplement their family income through self-employment and wage employment. The providing of employment/placement to the beneficiaries is not the mandate of the JSS Scheme. As far as the employment of the JSS scheme beneficiaries is concerned, third party evaluation report of the scheme has mentioned, "It is finally observed that as an impact of the training programme conducted at JSSs, the self and wage employment and private job have become evident". The usefulness of the scheme would be further self-evident from the fact that same report has mentioned that 77.05% of the beneficiary trainees have under gone occupational shifts.

**ITIs:** The final report of Tracer Study of ITI Graduates (published in January 2018 by the Ministry of Skill Development & Entrepreneurship, mentions that 63.5% of total ITI pass-outs got employed (wage+ self, out of which 6.7% are self-employed) and 36.4% remained unemployed and was looking for jobs.

- (d) No, Sir.
- (e) National Council for Vocational Education and Training (NCVET) has mandated that all trainers in ITIs need to be Crafts Instructor Training Scheme (CITS) trained. Directorate General of Training, under the Ministry of Skill Development and Entrepreneurship (MSDE) is inter-alia implementing the CITS all over India through 33 National Skill Training Institutes(NSTIs),out of which 19 are exclusively for women. Such trainers are trained in National Skill Training Institutes (NSTIs) and Institutes of Training of Trainers (IToTs).

Also, National Skill Development Corporation (NSDC), under the MSDE, is implementing a training program for the professional development of Skill Trainers and Assessors in the short-term skill eco-system. This program is for the development of professionals who are already associated/employed with Training Providers. Some of the salient features of the program are as follows:

- i. The Training of Trainers(ToT) and Training of Assessors (TOA) programs are implemented through the Sector Skill Councils(SSCs) for their respective job role requirements at dedicated To centres/ Trainer-Assessor Academies/ Center of Excellence.
- ii. Eligibility of Trainers and Assessors is aligned with the qualification requirements.
- iii. The training program covers orientation and assessment on the domain and platform skills/assessment skills for trainers and assessors respectively.
- iv. The training curriculum for ToT and TOA programs is based on the National Skills Qualifications Framework (NSQF), aligned qualifications.
- v. Trainers and Assessors are offered two certifications Basic certification with validity of 2 years and Advanced Certification with longer validity.
- vi. *Takshashila*, a dedicated technology platform has been developed for ease of operations, and for ensuring transparency and minimizing information asymmetry amongst stakeholders.
