(a) to (d): The Ministry of Tourism has provided financial assistance under the 'Swadesh Darshan' & 'National Mission on Pilgrimage Rejuvenation and Spiritual, Heritage Augmentation Drive (PRASHAD)' Schemes for the development of tourism related infrastructure in the country including Rajasthan.

Ministry of Tourism has also sanctioned projects under the 'Assistance to Central Agencies for Tourism Infrastructure Development' Scheme for the development of tourism related infrastructure in the country including Rajasthan.

The list of projects sanctioned under the 'Swadesh Darshan', 'PRASHAD' and 'Assistance to Central Agencies for Tourism Infrastructure Development' Schemes in the State of Rajasthan is given at Annexure.

Requests regarding developments at Bikaner, Brij Area of Rajasthan and Kolayat have been received in Ministry of Tourism.

Receiving proposals from the State Governments/UT Administrations/Central Agencies for financial assistance for tourism projects is a continuous process. The proposals received are examined with reference to the prescribed guidelines and financial assistance is extended for such projects subject to fulfilment of the stipulated conditions, operational viability and availability of funds.
