## PROGRESS OF DISHA INITIATIVES

# 363. SHRI P.P. CHAUDHARY: SHRI BRIJBHUSHAN SHARAN SINGH: SHRI SANGAM LAL GUPTA:

Will the Minister of RURAL DEVELOPMENT be pleased to state:

- (a) the progress of the DISHA initiative since its initiation, State-wise;
- (b) the progress of schemes in Rajasthan and Uttar Pradesh after introduction of DISHA;
- (c) the details of meetings of the DISHA Committee headed by public representatives during the last three years;
- (d) the details of discrepancy, if any, found out in such meetings and the details of action taken in this regard; and
- (e) whether meeting count and minutes are regularly updated on portal, if so, the details thereof and if not, the reasons therefor?

#### ANSWER

# MINISTER OF STATE IN THE MINISTRY OF RURAL DEVELOPMENT (SADHVI NIRANJAN JYOTI)

(a) & (c) The District Development Coordination and Monitoring Committee (DISHA) functions both at State/ Union Territory (UT) and district levels. At present, district-level DISHA Committees have been constituted in 711 districts in the country, while as reported by the States/ UTs, the State/ UT-level DISHA Committees have been constituted in ten States/ UTs. The details are enclosed in **Annexure –I**.

(b) The DISHA was constituted in June 2016 and meetings of the Committees have an important role in the effective implementation of various schemes of the Government of India across the States and Union Territories (UTs), including Rajasthan and Uttar Pradesh. The comparative progress of schemes implemented by the Department of Rural Development in Rajasthan and Uttar Pradesh after introduction of DISHA under major performance indicators during the last four years is given as below:
