Policy on Education Technology

3640. SHRI SYED IMTIAZ JALEEL:

Will the Minister of EDUCATION be pleased to state:

- (a) whether a policy on Education Technology (EdTech) is being prepared by the Government and if so, the details thereof;
- (b) whether the Central Government has constituted/appointed any Committee/Agency to review the EdTech products before they are used in classrooms;
- (c) if so the details of the Committee/Agency along with their budget and human resources;
- (d) if not, which mechanism is being followed to review the EdTech products;
- (e) the list of various companies that have entered into PPP or other arrangement with Ministry of Education for delivery of EdTech product or service along with the nature of service provided/to be provided by the concerned companies and quantum of resources committed by the Government to the company *in lieu* of the same; and
- (f) whether the Government is considering for release of such policy and if so, the details thereof and time by which it is likely to be released?

ANSWER MINISTER OF STATE IN THE MINISTRY OF EDUCATION (DR. SUBHAS SARKAR)

(a) to (f) Ministry of Education through an advisory issued on 23rd December 2021 has reiterated that EdTech firms, which may be considered e-commerce entities, have to comply to Consumer Protection (E-Commerce) Rules, 2020 for e-commerce firms (which were notified by the MINISTRY OF CONSUMER AFFAIRS, FOOD AND PUBLIC DISTRIBUTION (Department of Consumer Affairs)). The advisory further details many safeguards for various stakeholders in education ecosystem when opting for products or services from EdTech companies. University Grant Commission (UGC) has also notified regulations for offering full-fledged online programme by the Higher Educational Institutions (HEIs) which prohibit any franchise arrangement between HEIs with EdTech companies. Relevant advisory regarding the same is issued periodically by UGC and AICTE.

Ministry of Education has announced a National Educational Alliance for Technology (NEAT) as a Public-Private partnership model between the Government (through its implementing agency AICTE) and the EdTech companies. There are no resources committed by MoE for this arrangement. The list of companies and nature of service is at <u>Annexure</u>.
