CLASSIFICATION OF PROTECTED MONUMENTS

3641. SHRI RAJ KUMAR CHAHAR:

Will the Minister of Culture be pleased to state:

- (a) the total number of ticketed and non-ticketed ASI monuments in the country;
- (b) whether any classification of the protected monuments has been made, if so, the details and the lists thereof;
- (c) the number of missing monuments in the country;
- (d) the number of monuments which have a cultural notice board with its lists; and
- (e) whether the Government is aware that non-ticketed and less popular protected monuments should not have a limit of 100 meters around them as prohibited area?

ANSWER

- (a) There are 3693 monuments/sites declared as of national importance under the Ancient Monuments and Archaeological Sites and Remains (AMASR) Act, 1958 in the country, out of which entry fee is charged at 143 locations.
- (b) For entry fee purpose monuments have been divided into two groups. Group 'A'- monuments inscribed on World Heritage list, Group 'B'- others. Category 'A' has 20 entries and remaining 123 are under Category 'B'. The details of protected monuments are on ASI website www.asi.nic.in
- (c) 24 monuments/sites are untraceable.
- (d) List of monuments having cultural notice boards is provided at Annexure.
- (e) Under section 20A of the AMASR Act area extending to a distance of one hundred meters from the limit, of the protected monument is prohibited area. Some of the monuments have a larger area notified as prohibited area.
