RANKING OF SKILL DEVELOPMENT CENTRES

3666. SHRI OMPRAKSASH BHUPALSINH aliasPALWAN RAJENIMNALAKAR: SHRIMATI DELKAR KALABEN MOHANBHAI: SHRI ARVIND GANPAT SAWANT:

Will the Minister of SKILL DEVELOPMENT AND ENTREPRENEURSHIP be pleased to state:

- (a) the details of Skill Development Centres established in the country, State/Union Territory-wise including Maharashtra, Dadra and Nagar Haveli and Daman and Diu;
- (b) the ranking of the States including Maharashtra, Dadra and Nagar Haveli and Daman and Diu with respect to Skill Development and Entrepreneurship along with the steps taken by the Government to improve the ranking;
- (c) the total number of persons trained so far in these Skill Development Centres since their establishment;
- (d) whether the person trained in these skill development centres have got suitable employment in the market;
- (e) if so, the details thereof, state/UT-wise;
- (f) the action plan proposed by the Government to do away with the existing lacunae in the training module of these skill development centres;
- (g) the details of the funds allocated/utilized for training in these skill development centres, State/UT-wise including Tamil Nadu, Dadra and Nagar Haveli and Daman and Diu:
- (h) whether the Government proposes to promote the partnership of youth and women in the skill training programmes;
- (i) if so, the details thereof; and
- (j) the steps taken by the Government to promote partnership of youth and women in skill training program

ANSWER

MINISTER OF STATE IN THE MINISTRY OF SKILL DEVELOPMENT AND ENTREPRENEURSHIP (SHRI RAJEEV CHANDRASEKHAR)

- (a) Under Skill India Mission, the Ministry of Skill Development and Entrepreneurship (MSDE) has been delivering short term and long term skills through Pradhan Mantri Kaushal Vikas Yojana (PMKVY), Jan Shikshan Sansthan (JSS) Scheme, National Apprenticeship Promotion Scheme (NAPS) and Craftsman Training Scheme (CTS)/ Industrial Training Institutes (ITIs) across the country. The details of the Skill Development Centres established in the country under these schemes, State/Union Territory-wise including Maharastra, Dadra and Nagar Haveli and Daman and Diu are at **Annexure-I**.
- (b) There is no system of maintaining ranking of the States.

(c) The total number of persons trained under various Skill Development schemes viz. PMKVY, NAPS, JSS and ITIs are at **Annexure-II**, **Annexure-II**, **Annexure-IV** and **Annexure-V**.

(d)&(e)Amongst the schemes of the MSDE, only in the case of the PMKVY, placement was mandatory. Placement is not tracked in other schemes. However, third party evaluation reports have mentioned about success in terms of placement or increases in income of candidates trained under different schemes. The brief details of the same are as given below:

PMKVY: Placement percentage attained across the country at an aggregate as well as state level under PMKVY is attached at **Annexure VI**. As per the Third Party Evaluation Report on PMKVY, it was found that average monthly income of PMKVY trained and certified individuals was 15% higher than the comparison group. Moreover, 76% of the candidates acknowledged that after the training, they have better chance of getting employment.

JSS: The objective of training imparted under JSS is to link the individuals for gainful livelihood and supplement their family income through self-employment and wage employment. The providing of employment/placement to the beneficiaries is not the mandate of the JSS Scheme. As far as the employment of the JSS scheme beneficiaries is concerned, third party evaluation report of the scheme has mentioned, "It is finally observed that as an impact of the training programme conducted at JSSs, the self and wage employment and private job have become evident". The usefulness of the scheme would be further self-evident from the fact that same report has mentioned that 77.05% of the beneficiary trainees have under gone occupational shifts.

ITIs: The final report of Tracer Study of ITI Graduates (published in January 2018 by the Ministry of Skill Development & Entrepreneurship, GoI) mentions that 63.5% of total ITI pass-outs got employed (wage+ self, out of which 6.7% are self-employed) and 36.4% remained unemployed and was looking for jobs.

NAPS: Since NAPS is an apprenticeship related scheme, no placement is tracked.

- (f) As envisaged in the National Policy for Skill Development and Entrepreneurship 2015, the Ministry of Skill Development and Entrepreneurship has been undertaking regular monitoring and evaluation of its various schemes/initiatives for any necessary corrective measures. Procedural changes are introduced in the schemes on the basis of feedbacks, various internal studies. For example, in the version 3.0 of thePMKVY, lessons of both versions 2.0 and 3.0 and Third Party Evaluation studies were incorporated for better results.
- (g) The details of funds allocated for training in these skill development centres through various schemes viz. PMKVY, NAPS, JSS and CTS/ITIs State/UT-wise including Tamil Nadu, Dadra and Nagar Haveli and Daman and Diu are at **Annexure-VII**, **Annexure-VIII**, **Annexure-IX** and **Annexure-X** respectively.
- (h) Yes, Sir.
- (i) & (j)Inclusive skill development, with the objective of increased women participation forbetter economic productivity is one of the focus areas of the National Policy on SkillDevelopment & Entrepreneurship, 2015. Also, following special provisions are made to support the women candidates under Common Norms:

- (i) Organizing of training programmes anywhere in the country where women trainees have to travel more than 80 kms from their homes to reach the nearest training centre and for availing boarding and lodging arrangements.
- (ii) Post placement support is provided directly to the women candidates, at the rate of Rs. 1500/- per month (upto two months for placement within District of domicile and 3 months for placement outside District of domicile)

In JSS, focus is given to Women, SC, ST, OBC and Minorities. The Third-Party Evaluation study report conducted by Indian Institute of Public Administration (IIPA) during2020-21 has shown that this scheme is very effective for empowerment of women since therepresentation of women is around 80%.

Under PMKVY, in order to increase the participation of women, conveyance cost and boarding & lodging facilities are being provided for them. The priority group under JSS includes women. Under long term skilling, Directorate General of Training (DGT), vocationaltrades particularly suitable for women are identified and their implementation is planned. Theidentified trade promote women wage-employment in industry as instructors and also promotes their self-employment.

National Skill Training Institutes (NSTIs) also offers courses under CraftsmenTraining Scheme (CTS) in 33 NSTIs, (NSTIs General (14), NSTIs Women (19)) across thecountry and 2 Extension Centers. The NSTIs are offering training in new age courses since2019 under Dual System of Training (DST) scheme to partner with Industries andestablishments for conducting training under these technologies driven courses and fulfiltheir skilled manpower requirements. In addition, 30% of the seats in General IndustrialTraining Institutes (ITIs) are reserved for women trainees subject to the general reservationpolicy of the respective State.

Directorate General of Training (DGT) under MSDE conducts vocational training for one year duration in 06 courses namely Computer Aided Embroidery & Designing, DressMaking, Fashion Design and Technology, Sewing Technology, Cosmetology and SpaTherapy under CTS to increase as well as encourage women participation in ITIs.Additionally, a compulsory subject 'Employability Skills' has included in curriculaof schemes under CTS covering topic mainly "English Literacy, I.T. Literacy, Communication Skills & Entrepreneurship Skills with a duration of 90 hours forone yearcourses for awareness of trainees on soft skills and entrepreneurial skills.

Under the aegis of MSDE, National Institute of Entrepreneurship and Small Business Development (NIESBUD) has been working for the empowerment, upliftment anddevelopment of women across the country. The institute conducts Entrepreneurship orientation programmes, Entrepreneurship Awareness Programmes, Entrepreneurship Development Programmes (EDP) and Entrepreneurship Skill Development Programmes (ESDP), Women Entrepreneurship Development Programmes (WEDP), for women whowish to become self-reliant or start innovative businesses. The focus is on encouragingwomen entrepreneurs through appropriate incentives for women owned businesses underthe public procurement process. NIESBUD has designed Entrepreneurship Development Programmes for the rural women with the objective to inculcate entrepreneurial values, attitude and motivation among the rural women to take up challenges to set up anenterprise/group enterprise.
