Projects Funded by NSDF

383. SHRI RAMDAS C. TADAS:

Will the Minister of YOUTH AFFAIRS AND SPORTS be pleased to state:

(a) the details and objective of the National Sports Development Fund (NSDF) and the criteria for allocation of funds;

(b) the funds available with the NSDF presently and during the years from 2014 to 2022;

(c) the procedure for sports federations or other bodies to apply for funds and the time limit to accord approval or rejection for the same;

(d) the projects funded by the NSDF along with the amount provided for each of the projects during the last five years and the current year, State/UT-wise; and

(e) the details of projects currently under consideration of the NSDF?

**ANSWER

(a): The National Sports Development Fund (NSDF) was established in 1998 under the Charitable Endowments Act 1890 and was notified by Government of India in November, 1998. The Fund

helps sportspersons excel by providing them opportunities to train under coaches of international repute with technical, scientific and psychological support and giving them exposure to international competitions. The Fund also provides financial assistance for development of infrastructure and other activities for promotion of sports.

The following are the objectives of NSDF:

- i. To administer and apply the moneys of the fund for promotion of sports in general and specific sports disciplines and individual sports persons in particular for achieving excellence at the National and International level;**
- ii. To impart special training and coaching in relevant sports disciplines to sportsperson, coaches and sports specialists;**
- iii. To construct and maintain infrastructure as may be required for promotion of excellence in sports;**
- iv. To supply equipment to Government and Non-Government Organizations and individuals with a view to promoting excellence in sports;**
- v. To identify problems and take up research and development studies for providing support to excellence in sports;**
- vi. To promote international cooperation, in particular, exchanges which may promote the development of indigenous sport and human resources as also the activities which are within the ambit of Exchange Programmes entered into between India and other countries; and**
- vii. To provide low interest or interest free loans for projects and activities related to any of the aforesaid objects.**

(b): The details of funds available with the NSDF presently and during the years from 2014 to 2022 are as under:

(c): Sportspersons / organisations etc. desirous of seeking financial assistance / grants from the NSDF are required to apply in the prescribed form along with the detailed project report, time schedule for completion of the project and financial implications, etc.

The Executive Committee of NSDF considers all the proposals and takes appropriate decision after getting comments from the concerned authorities / organisations / agencies. There is no specific time limit to accord approval or rejections for the same.

(d): Details of the projects approved for financial assistance from NSDF along with the amount provided for each of the projects are given at Annexure.

(e): The Union Government keeps receiving proposals from individual sportspersons, organisations / institutes, etc. from time to time. The proposals are sanctioned according to the parameters of the NSDF scheme subject to their completeness, technical feasibility and availability of funds under the scheme. Based on the proposals received under the scheme, 32 projects of various categories have been sanctioned under the NSDF scheme during the last five years.
