Will the Minister of AGRICULTURE AND FARMERS WELFARE कृषि एवं किसान कल्याण मंत्री be pleased to state:

- (a) whether the Government has taken any initiative to provide remunerative prices to farmers by considering the policy of dynamic pricing of Kharif crops, etc proportional to the market prices, if so, the details thereof;
- (b) whether the Government raised the Minimum Support Price (MSP) of kharif crops for 2022-23 by around 5-9 per cent and the biggest hikes were reserved for pulses and oilseeds and also for jowar to encourage its cultivation;
- (c) if so, the details thereof comparatively since 2014 till date, State-wise, crop-wise and MSP-wise including Uttarakahand and Bundelkhand and the actual demands of the farmers met/ignored by the Government along with the reasons therefor;
- (d) whether any study has been conducted to assess the impact of MSP and its likely benefit to farmers;
- (e) if so, the details thereof and if not, the reasons therefor; and
- (f) the other measures being taken to increase farmers income in proportion to cost of cultivation?

ANSWER

THE MINISTER OF AGRICULTURE AND FARMERS WELFARE

(a) & (b): Government announces Minimum Support Price (MSP) to ensure remunerative prices to the growers for their produce and encourage higher investment and production. The Government in its Union Budget for 2018-19 had announced the pre-determined Principle to keep MSP at levels of one and half times of the cost of production. Accordingly, Government has increased the MSP for all mandated Kharif, Rabi and other commercial crops with a return of atleast 50 per cent over all India weighted average cost of production from the agricultural year 2018-19 onwards. In line with the same principle, Government has recently announced the increase in MSP for all mandated kharif crops of year 2022-23 on 8th June, 2022.

Government has made concerted efforts for increasing production of oilseeds, pulses and nutri-cereals so as to encourage farmers to increase productivity by adopting best technologies and farm practices and to correct demand – supply imbalance.

Cost of production is one of the important factors in the determination of MSP. While recommending its price policy, the CACP considers all costs in a comprehensive manner. CACP projects the cost of production for the current year on the basis of Composite Input Price Index (CIPI) which measures the change in input price over previous year. The CIPIs are based on latest prices of major inputs like human labour, bullock labour, machine labour, fertilisers and manures, seeds, pesticides and irrigation as per data available from different ministries/ departments.

- (c): MSP is determined for the country as a whole and not region or state-specific. However, region-specific parameters are also kept in view by CACP while recommending MSP. CACP holds consultations with stakeholders and seeks suggestions for both price and non-price recommendations before finalizing its recommendations on MSP. The details of MSP form 2014-15 are given at Annex 1.
- (d) & (e): The NITI Aayog (erstwhile Planning Commission) has conducted a study entitled "Efficacy of minimum support prices on farmers", 2016. The study covered 14 States, 36 Districts, 72 Blocks, 144 Villages and 1440 Households. The study is based on both the primary and secondary data. The study has found, among other things, that MSP declared by the Government has encouraged 78 % of the farmers covered under the study for adopting improved methods of farming such as high yielding varieties of seeds, organic manure, chemical fertilizer, pesticides and improved methods of harvesting etc.
- (f): MSP is one of the measures for remunerative prices to farmers. Moreover, Government has taken a "multi pronged approach" to increase the income of farmers and has been implementing/reorienting various schemes for the same which include Soil Health Card (SHC), Pradhan Mantri Kisan Samman Nidhi (PM-KISAN), Pradhan Mantri Krishi Sinchayee Yojana (PMKSY), e-NAM, Pradhan Mantri Fasal Bima Yojana (PMFBY), Pradhan Mantri Annadata Aay Sanrakshan Abhiyan' (PM-AASHA), Agriculture Infrastructure Fund, promotion of 10,000 FPOs, a special dedicated scheme on Agriculture Mechanization (SMAM) etc. among others.
