### 530. SHRI VISHNU DATT SHARMA:

Will the Minister of ELECTRONICS AND INFORMATION TECHNOLOGY be pleased to state:

- (a) the number of people in the country in general and Madhya Pradesh in particular who remained to be issued Aadhaar number by UIDAI;
- (b) the efforts being made and the outcomes achieved in covering these uncovered people;
- (c) whether any data has been maintained on citizens without hands or clear fingerprints who are still not issued Aadhaar number, if so, the details thereof; and
- (d) the provisions that has been made to issue Aadhaar number to people without hands or clear fingerprints?

#### **ANSWER**

# MINISTER OF STATE FOR ELECTRONICS AND INFORMATION TECHNOLOGY (SHRI RAJEEV CHANDRASEKHAR)

(a): As per RGI data, the total projected population (2022) of India is 137.30 crore (approx). As on 30th June 2022, a total of 133.586 crore Aadhaars have been generated. However, the actual number of Aadhaar holders would be lesser due to deaths. Hence, the concept of "Live Aadhaar" has been introduced to estimate the number of persons holding Aadhaar who are alive. It is estimated that the number of Live Aadhaars stands at 127.79 crore. Based on this information, it can be concluded that a population of around 9.51 crore are yet to enroll for Aadhaar, out of which 8.30 crore are children in the age group of 0-5 years.

Similarly, the total projected population (2022) of Madhya Pradesh is 8.55 crore (approx). Further, Live Aadhaar in Madhya Pradesh is estimated at 7.63 crore (approx). It can be concluded that a population of around 92.01 lakh are yet to enroll for Aadhaar, out of which 67.29 lakh are children in the age group of 0-5 years.

The Aadhaar Saturation Report as on 30th June, 2022 is attached as Annexure-I.

(b): UIDAI has on-boarded various Central/ State Government Departments including Department of Posts, Women & Child Development Department, School Education Department, Scheduled Commercial Banks, Navodaya Vidyalaya Samiti, BSNL, CSC, UTIITSL, IPPB etc. as Registrars for providing Aadhaar enrolment & update services to the residents. In addition to this, UIDAI is in the process of establishing and running Aadhaar Seva Kendras (ASKs) at selected cities across the country through its Service Providers.

UIDAI is making all out efforts for covering the left out population for Aadhaar and the same is evident from the fact that as on 30th June, 2022, around 57,000 Aadhaar counters were operational throughout India. In addition, nearly 34,000 Mobile/Tablet based Child Enrolment Lite Client (CELC) are also functional specially for carrying out Aadhaar enrolment of children in 0-5 age group.

- (c): Every person who has approached UIDAI has been issued Aadhaar irrespective of resident not having hands or clear fingerprints.
- (d): The provision is made in Regulation 6(1) of the Aadhaar (Enrolment & Update) Regulations, 2016, which lays down that "For residents who are unable to provide fingerprints, owning to reasons such as injury, deformities, amputation of the fingers/ hands or any other relevant reason, only Iris scans of such residents will be collected".
