- (a) the details of the funds allocated to various States for the implementation of all the schemes under National Handloom Development Programme (NHDP) during the last three years, State-wise?
- (b) the percentage of the funds allocated which has been utilised for the beneficiaries during the last three years;
- (c) the State-wise details of the number of beneficiaries who have been benefitted from these schemes?

- (d) whether the government is considering any new schemes under this programme and if so, the details thereof?

(a) to (d): Ministry of Textiles is implementing National Handloom Development Programme from 2021-22 to 2025- 26 with merger of two schemes viz. Comprehensive Handloom Cluster Development Scheme and Handloom Weavers Comprehensive Welfare Scheme. Under this scheme, funds are not allocated State-wise. However, funds are released based on the proposals received from the States/UTs. Also, 2nd instalment under the scheme is released after utilisation of 70% of funds released in 1st instalment. State-wise detail of funds released during last three years is annexed.
