DRINKING WATER PROJECTS IN ANDHRA PRADESH

696. SHRI Y.S. AVINASH REDDY:

Will the Minister of JAL SHAKTI be pleased to state:-

- (a) the details of the drinking water projects taken up from 2014 till date in the State of Andhra Pradesh, district-wise; and
- (b) the details of total funds allocated and utilized under various schemes in the said State?

ANSWER

THE MINISTER OF STATE FOR JALSHAKTI (SHRI PRAHLAD SINGH PATEL)

(a) & (b) Water is a State subject. Government of India supplements the efforts of State Governments by providing financial and technical assistance. It is States, who plan, approve, implement, operate and maintain drinking water supply schemes.

Till 2019, the Government of India in partnership with States, was implementing National Rural Drinking Water Program (NRDWP) for improving the coverage of drinking water supply in the rural areas of the country. Thereafter, Jal Jeevan Mission (JJM) was launched in 2019 to provide tap water supply to every rural household of the country by 2024. The details of individual scheme/ projects under JJM (erstwhile NRDWP) in States are approved, implemented and maintained by the respective State Government or itsagency, responsible for the implementation in the field.

The year-wise details of total fund allocation made and the quantum of fund utilized under NRDWP/JJM, as reported by State of Andhra Pradesh, are at **Annex**.
