NAYA SAVERA SCHEME

710. SHRI PALLAB LOCHAN DAS :

Will the Minister of MINORITY AFFAIRS be pleased to state:

- (a) whether Naya Savera Scheme has been implemented in Assam;
- (b) if so, the number of beneficiaries under this scheme in Assam especially in Tezpur Parliament Constituency, year-wise;
- (c) the details of funds allocated to North Eastern States under various schemes implemented by the Government during the last three years; and
- (d) the details of funds allocated to and spent by North Eastern States especially Assam for the said schemes during the last three years?

ANSWER

THE MINISTER OF MINORITY AFFAIRS
(SMT. SMRITI ZUBIN IRANI)

(a) Yes, Sir. Ministry of Minority Affairs implements Free Coaching and Allied Scheme (Naya Savera) to assist students/candidates belonging to the six notified minority communities namely Sikh, Jain, Muslim, Christian, Buddhist and Parsi by way of special coaching for qualifying examinations for admission in technical/professional courses and competitive examination for recruitment to Group 'A', 'B', & 'C' services and other equivalent posts under the Central and State Governments including public sector undertakings, banks, insurance companies as well as autonomous bodies. The scheme is implemented across the country including Assam through empaneled Project Implementing Agencies (PIAs) / Non-Government Organizations (NGOs) since 2007-08.

(b) 100 students were allocated for two centers in Kamrup district of Assam State during 2017-18 and another 100 students in 2019-20 under the Naya Savera scheme.

(c)& (d).Details of funds allocated and released to North Eastern states including Assam for various schemes implemented by North Eastern Council (NEC), Ministry of Development of North Eastern Region, during the last three (3) years are given at Annexure-I.

Apart from the above, Ministry of Minority Affairs also implements various schemes for socio-economic empowerment for the six notified minority communities. The details of funds released by the Ministry in the North Eastern region including Assam, during the last three years are given in Annexure-II.
