#### CITIES UNDER SMART CITIES MISSION

## NO. 745. SHRI RAJESHBHAI CHUDASAMA: SHRI C.R. PATIL:

Will the Minister of HOUSING AND URBAN AFFAIRS be pleased to state:

- (a) the details of cities identified in Gujarat under Smart Cities Mission (SCM);
- (b) the status of implementation/completion of various projects in the above identified cities, city and project-wise during the last three years and the current year;
- (c) the funds disbursed so far for smart cities in the said State during the last five years;
- (d) whether any request has been received by the Government from the State Government of Gujarat for inclusion of more city corporations under SCM; and
- (e) if so, the details of the action taken with regard to the above request?

#### **ANSWER**

## THE MINISTER OF STATE IN THE MINISTRY OF HOUSING AND URBAN AFFAIRS (SHRI KAUSHAL KISHORE)

(a) to (e): Government of India launched the Smart Cities Mission (SCM) on 25 June 2015 for development of 100 cities as Smart Cities. The selection of 100 Smart Cities has been completed through 4 rounds of selection from January 2016 to June 2018. In the State of Gujarat 6 cities namely Ahmedabad, Dahod, Gandhinagar, Rajkot, Surat & Vadodara have been selected for development as Smart Cities. The present status of physical progress in Smart City projects and funds released by the Central Government to the Smart Cities in Gujarat are given in Annexure-I.

No proposal has been received from the State Government of Gujarat for inclusion of more city corporations under SCM.
