CONTAMINATION OF DRINKING WATER WITH FLUORIDE AND ARSENIC

†771. SHRI VISHNU DAYAL RAM:

Will the Minister of JAL SHAKTI be pleased to state:

- (a) the details of States across the country which have been affected due to contamination of drinking water with fluoride and arsenic elements;
- (b) the steps taken/being taken by the Government to provide safe drinking water to such States including Jharkhand; and
- (c) whether the Government is providing any special assistance to these States in this regard and if so, the details thereof along with the targets set for these States/UTs?

ANSWER

THE MINISTER OF STATE FOR JAL SHAKTI (SHRI PRAHLAD SINGH PATEL)

(a) to (c) To make provision of potable tap water supply in adequate quantity, of prescribed quality and on regular & long-term basis to every rural household in the country by 2024, since August, 2019, Government of India in partnership with States/ UTs, is implementing Jal Jeevan Mission (JJM) – Har Ghar Jal. Under JJM, while allocating the funds to States/ UTs, 10% weightage is given to the population residing in habitations affected by chemical contaminants.

Under JJM, while planning for potable water supply to household through tap water connection, priority is to be given to quality-affected habitations. Since, planning, implementation and commissioning of piped water supply scheme based on a safe water source may take time, purely as an interim measure, States/ UTs have been advised to install community water purification plants (CWPPs) especially in Arsenic and Fluoride affected habitations to provide potable water to every household at the rate of 8–10 litre per capita per day (lpcd) to meet their drinking and cooking requirements.

As reported by States/ UTs, State-wise details of number of habitations affected with Arsenic and Fluoride contamination in drinking water sources and coverage planning for 2022-23 are **annexed.**
